

**ROCKET MORTGAGE SUPER BOWL SQUARES 2021 SWEEPSTAKES**  
**OFFICIAL RULES**

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING.**

The Rocket Mortgage Super Bowl Squares 2021 Sweepstakes ("Sweepstakes") is sponsored by Quicken Loans, LLC ("Sponsor"), 1050 Woodward Avenue, Detroit, MI 48226, and is administered by Prize Logic, LLC ("Administrator"), 25200 Telegraph Road, Suite 405, Southfield, MI 48033.

- 1. SWEEPSTAKES PERIOD:** The Sweepstakes begins at 12:00 PM Eastern Time ("ET") on January 7, 2021 and ends at 11:59 PM ET on either February 4, 2021, or three (3) calendar days prior to Super Bowl LV, or as otherwise determined by Sponsor, whichever is later ("Sweepstakes Period"). Note: Super Bowl LV is scheduled for Sunday, February 7, 2021. If Super Bowl LV is postponed for any reason, the Sweepstakes Period will end at 11:59:59 PM ET three (3) days prior to the rescheduled date, or as otherwise determined by Sponsor in its sole and absolute discretion, and notice will be posted on the Website (as defined in Section 3). Administrator's computer is the Sweepstakes official clock.
- 2. ELIGIBILITY:** The Sweepstakes is open to legal residents of the fifty (50) United States and the District of Columbia, regardless of where they reside, who are at least eighteen (18) years old at the time of entry and of the age of majority in their state of residence (i.e., 19 years old in Alabama and Nebraska; 21 years old in Mississippi; 18 years old in all other states) ("Entrant"). Employees of Sponsor, Administrator, National Football League ("NFL"), its member professional football clubs, NFL Ventures, Inc., NFL Ventures, L.P., NFL Properties LLC, NFL Enterprises LLC, NFL Productions LLC, NFL International LLC and each of their respective subsidiaries, affiliates, shareholders, officers, directors, agents, representatives, and employees (collectively, "NFL Entities"), and their respective parent companies, affiliates, subsidiaries, franchisees, representatives, consultants, contractors, legal counsel, advertising, public relations, promotional, fulfillment, and marketing agencies, web site providers, and web masters (collectively, "Sweepstakes Entities"), and each of their immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the "steps" of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win a prize.

Participation constitutes Entrant's full and unconditional agreement to these Official Rules and to Sponsor's and/or Administrator's decisions, which are final and binding in all matters related to this Sweepstakes. For purposes of the Sweepstakes, an Entrant's residential address and e-mail address will be the physical address and e-mail address submitted at the time of entry. Entrants will not be allowed to change their physical address or e-mail address. Winning a prize is contingent upon fulfilling all requirements set forth herein. Entrants and/or the potential winners may be required to provide proof of identification and eligibility as requested by Sponsor or Administrator.

- 3. SWEEPSTAKES OVERVIEW:** To participate in the Sweepstakes an Entrant must follow the steps in Section 4 and as outlined at <https://rocketmortgagesquares.com> (“Website”) to register and select a square from the 10 row by 10 column chart. At the time of selection, no numbers will be assigned to each column and row of the chart. At the conclusion of the Sweepstakes Period, the Administrator will randomly assign each row and column with whole digits numbered 0 – 9 as well as team names for the x axis and y axis. Each “Square” correlates to a digit adjacent to each team name, based on the column and row of the Square. An Entrant may return to the Website beginning at 12:00 AM ET on February 5, 2021, or the day after the Sweepstakes Period ends, if Super Bowl LV is rescheduled, and enter their e-mail address to view their assigned Square that will match to the last digits in a score during the Super Bowl LV game scheduled to occur on February 7, 2021. The Sweepstakes includes two (2) grand prize drawings, each for a check for \$500,000, and up to thirty (30) first prize drawings, each for a check \$50,000, as further described in Section 6. By registering for the Sweepstakes and selecting a Square (as further described in Section 4), Entrants will receive one (1) entry into each grand prize drawing, regardless of assigned Square numbers. Entrants will receive one (1) entry into a first prize drawing if the last digit of each team’s score after an official and confirmed score change due to game play during Super Bowl LV (“Score Change”) matches their Square, up to the first thirty (30) score changes, as further described in Section 5. A Score Change will only become final and valid for purposes of this Sweepstakes upon a determination by the NFL officials designated to make such determination. Consequently, if a score is challenged and subsequently overturned by NFL officials, the challenged score will not be determined a Score Change. Throughout the broadcast of Super Bowl LV, potential winners will be announced on the Website and Sponsor’s social media accounts (first name, last initial, city and state of residence). **ALL WINNERS ARE DEEMED POTENTIAL WINNERS AND ARE SUBJECT TO VERIFICATION OF ELIGIBILITY. THE SELECTION OF A SQUARE ASSOCIATED WITH A SCORE CHANGE DOES NOT IMPLY THAT YOU HAVE WON A PRIZE.** In the event of fewer than thirty (30) Score Changes during Super Bowl LV, the maximum number of first prizes available to be won will be equal the actual number of Score Changes. In the unlikely event there are more than thirty (30) Score Changes, no additional first prizes will be awarded. In the event that Super Bowl LV does not take place as scheduled, the Sponsor reserves the right to modify the Sweepstakes to ensure the Sweepstakes can be conducted as intended.
- 4. HOW TO ENTER AND SELECT SQUARES:** During the Sweepstakes Period an Entrant must visit the Website and enter their e-mail address and click “CONTINUE.” If it is the first time an Entrant is entering the Sweepstakes, the Entrant must register by submitting the information requested on the registration form, which may include, without limitation: their first and last name (initials are not permitted), ZIP Code, telephone number, date of birth, and confirmation that they have read and agrees to be bound by these Official Rules. Upon submission of the registration information, the Entrant must then follow the on-screen instructions to select a Square and click “SUBMIT”. Once selected and submitted, an Entrant’s Square selection cannot be changed.

**How to Obtain Additional Squares:** During the Sweepstakes Period, an Entrant may obtain up to ten (10) additional Squares by following the instructions on the Website and set forth below to share the Sweepstakes on Facebook and/or Twitter. Upon clicking the buttons on the Website to share the Sweepstakes via Facebook and/or Twitter, a message with a unique link will be posted to the Entrant’s choice of their Facebook Wall and/or Twitter feed (“Invitation Post”). To obtain additional Squares, an Entrant’s Facebook “Friend” or Twitter follower must click on the unique link in the Entrant’s Invitation Post and complete and submit the registration information requested and select a Square, as outlined above, to enter the Sweepstakes. Upon the Friend’s/follower’s successful entry into the Sweepstakes, the original Entrant will receive one (1) additional Square. An Entrant will receive one (1) additional Square for each Friend/follower who enters the Sweepstakes by following

the unique link in the Invitation Post, up to a maximum of ten (10) additional Squares. The Entrant will be notified via e-mail when an additional Square is available, as well as notified at the Website upon submission of their e-mail address. Upon receipt of an additional Square, the Entrant must return to the Website, enter their e-mail address and follow the on-screen instructions to select their Square from the chart. Squares must be selected by Entrant during the Sweepstakes Period in accordance with the Website instructions. **Additional Squares available for an Entrant's selection, but not selected prior to the end of the Sweepstakes Period will be forfeited.**

**Limit:** An Entrant may only register for the Sweepstakes once. If more than one (1) registration is received from the same person, telephone number and/or e-mail address the entries may, at the Sponsor's sole discretion, be disqualified. An Entrant is limited to selecting a total of eleven (11) Squares during the Sweepstakes Period – one (1) at time of registration and up to ten (10) additional Squares using the unique link referral method outlined above. Entrants are prohibited from using more than one (1) e-mail address or multiple identities. If it is found or suspected that an Entrant is using more than one e-mail address or multiple identities to participate in the Sweepstakes, then that Entrant, in Sponsor's sole discretion, may not be eligible to win a prize. Automated methods to participate in this Sweepstakes are prohibited and the use of any automated or computer system to participate is prohibited and will result in disqualification.

**IMPORTANT:** MESSAGE AND DATA RATES MAY APPLY IF AN ENTRANT PARTICIPATES IN THIS SWEEPSTAKES ON THEIR MOBILE DEVICE. ## **5. RANDOM DRAWINGS:**

**A. Grand Prize Drawings:** On or about February 5, 2021, or in the event Super Bowl LV is postponed, one (1) day after the end of the Sweepstakes Period, the Administrator will randomly select two (2) potential grand prize winners from among all Entrants who completed the registration and selected a Square during the Sweepstakes Period ("Grand Prize Drawing"). All eligible Entrants will only be entered once into each Grand Prize Drawing, regardless of an Entrant's Square assignment.

**B. First Prize Drawings:** Throughout the broadcast of Super Bowl LV scheduled to occur on February 7, 2021, for each official and confirmed Score Change the last digit of each teams' score will be matched to the corresponding Square and a random drawing will be conducted from among all eligible Entrants with that Square to select one (1) potential first prize winner (each, a "First Prize Drawing"). Each First Prize Drawing will be comprised of Entrants who selected the Square that corresponds to the Score Change.

**C. General Conditions on Random Drawings:** Potential winners will be announced (first name, last initial, city and state of residence) at both the Website and on the Sponsor's social media channels throughout the broadcast of Super Bowl LV scheduled to occur on February 7, 2021. Posting of a potential winner at the Website and/or Sponsor's social media channels DOES NOT imply the potential winner is a verified winner. Each winner is considered a potential winner pending verification of eligibility and compliance with these Official Rules, as set forth in Section 7 of these Official Rules. All random drawings will be conducted by the Administrator whose decisions are final on all matters relating to this Sweepstakes.

**6. PRIZES, APPROXIMATE RETAIL VALUE (“ARV”), AND ODDS OF WINNING:**

- A. Grand Prizes (2):** Each grand prize is a check made payable to the grand prize winner in the amount of USD \$500,000 from Rocket Mortgage (“Grand Prize”). Two (2) Grand Prizes will be available in the Sweepstakes. The ARV of each Grand Prize is \$500,000.
- B. First Prizes (up to 30):** Each first prize is a check made payable to the first prize winner in the amount of USD \$50,000 from Rocket Mortgage (“First Prize”). Up to thirty (30) First Prizes will be available in the Sweepstakes, depending on the total number of Score Changes that occur during Super Bowl LV. Under no circumstances will more than thirty (30) First Prizes be awarded in the Sweepstakes, however, fewer than thirty (30) First Prizes may be available, depending on the total number of Score Changes during Super Bowl LV. The ARV of each First Prize is \$50,000.
- C. Total ARV:** The total ARV of all available prizes in the Sweepstakes is up to \$2,500,000.
- D. Odds of Winning:** The odds of winning a Grand Prize depend on the number of eligible Entrants who register during the Sweepstakes Period. The odds of winning a First Prize depend on the number of eligible Entrants that select a Square that corresponds to the last digit of each teams’ score after each Score Change in Super Bowl LV.
- E. General Conditions on Prizes:** In no event will more prizes than are stated in these Official Rules be awarded. If, for any reason, more prize notifications are sent (or more claims are received) than the number of prizes offered, as set forth in these Official Rules, Sponsor reserves the right to award the intended number of prizes through a random drawing from among all eligible prize claims received. Limit of one (1) Grand Prize and one (1) First Prize per Entrant/household. An Entrant/household may win both a Grand Prize and a First Prize. No prize substitution or exchange will be allowed, except by Sponsor, who reserves the right to substitute a prize of equal or greater value in case of unavailability of a prize or force majeure. Each winner shall be solely responsible for payment of any and all applicable federal, state, and local taxes for any prize won. All other costs and expenses not expressly set forth herein shall be solely the winner’s responsibility. The Sweepstakes Entities shall not be held responsible for any delays in awarding a prize for any reason. If after a good-faith attempt Sponsor is unable to award or deliver a prize, the prize may not be re-awarded.

- 7. HOW TO CLAIM A PRIZE:** Potential winners are subject to verification of eligibility and compliance with these Official Rules. Potential Grand Prize winners will be notified by telephone and e-mail on or about February 5, 2021, or the same day as the Grand Prize Drawings, in the event Super Bowl LV is postponed, and each potential First Prize winner will be notified by telephone or e-mail within approximately ten (10) minutes after the applicable First Prize Random Drawing triggered by an official and verified Score Change. Potential winner notifications will include instructions on how to claim a prize and all potential winners will be required to sign and return an Affidavit of Eligibility and Liability/Publicity Release (except where prohibited) and any other requested documents (collectively, the “Affidavit”). Potential Grand Prize winners must return the Affidavit within twenty-four (24) hours from the time of attempted notification, and potential First Prize winners must return the Affidavit within eight (8) calendar days from the date of attempted notification or the prize may be forfeited in its entirety and awarded to an alternate winner, at the Sponsor’s sole and absolute discretion. Failure to provide all required information and signed documents within the stated time period may result in forfeiture of winner’s right to claim a prize and may result in the prize being awarded to an alternate winner, if time permits. Each potential winner may be subject to a background check before the prize

is awarded. Sponsor reserves the right to disqualify the potential winner based on the results of such background check if Sponsor determines in its sole discretion that awarding the prize to any such individual might reflect negatively on the Sponsor. As a condition of accepting their prize, winners may be required to participate in reasonable press or other public relations activities as requested by Sponsor. Failure to provide all required information and a signature on the documents within the stated time period may result in forfeiture of a winner's right to claim a prize, and may result in the prize being awarded to an alternate winner, if time permits. If a potential winner is disqualified, found to be ineligible or not in compliance with these Official Rules, declines to accept a prize, the respective prize may be forfeited. If a prize is forfeited, the prize may be awarded to an alternate winner, selected in a random drawing from among all remaining eligible Entrants, as determined by Sponsor in its sole discretion. If, after a good-faith attempt, Sponsor is unable to award or deliver a prize, the prize may not be re-awarded. Prizes will be mailed to the winners at the physical addresses (P.O. Boxes are not permitted) provided at the time of registration within 6 to 8 weeks from verification of eligibility and compliance with these Official Rules. Prizes will only be mailed to addresses within the fifty (50) United States or District of Columbia. Any portion of a prize not accepted by a winner will be forfeited. Each winner shall be solely responsible for payment of any and all applicable federal, state, and local taxes for their prize won. Sponsor will issue an IRS Form 1099-MISC for each winner, and each winner must provide Administrator with a valid social security number or tax identification number for tax reporting purposes. All other costs and expenses not expressly set forth herein shall be solely each winner's responsibility. Each prize will only be awarded to a verified winner.

Sponsor will attempt to notify each potential winner as set forth above, but Sponsor is not responsible for any undelivered e-mails, including without limitation e-mails that are not received because of a winner's privacy or spam filter settings which may divert any Sweepstakes e-mail, including any winner notification e-mail, to a spam or junk folder. Prizes that are unclaimed, unredeemed, or returned as undeliverable will not be awarded. Prizes are non-transferable and no prize substitution or exchange will be allowed, except by Sponsor, who reserves the right to substitute a prize of equal or greater value in case of unavailability of the prize or force majeure, at Sponsor's sole and absolute discretion. Sweepstakes Entities shall not be held responsible for any delays in awarding the prize for any reason.

- 8. LIMITATION OF LIABILITY:** By participating in this Sweepstakes, Entrants agree (and agrees to confirm in writing if requested) that the Sweepstakes Entities, Facebook Inc., Twitter, Inc., and each of their respective affiliates, subsidiaries, franchisees, representatives, consultants, contractors, legal counsel, advertising, public relations, promotional, fulfillment and marketing agencies, website providers, web masters, and their respective officers, directors, employees, representatives and agents ("Released Parties") are not responsible for: (i) lost, late, incomplete, stolen, misdirected, postage due or undeliverable e-mail notifications or postal mail; (ii) any computer, telephone, satellite, cable, network, electronic or Internet hardware or software malfunctions, failures, connections, or availability; (iii) garbled, corrupt or jumbled transmissions, service provider/network accessibility, availability or traffic congestion; (iv) any technical, mechanical, printing or typographical or other error; (v) the incorrect or inaccurate capture of registration information or the failure to capture, or loss of, any such information; (vi) any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical error, theft or destruction or unauthorized access to the Sweepstakes; (vii) any injury or damage, whether personal or property, to Entrants or to any person's computer related to or resulting from participating in the Sweepstakes and/or accepting a prize; and (viii) Squares that are late, forged, lost, misplaced, misdirected, tampered with, incomplete, deleted, damaged, garbled or otherwise not in compliance with the Official Rules. IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY JUDICIAL ARBITRATION AND MEDIATION SERVICES, INC., IN ACCORDANCE WITH ITS STREAMLINED ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF ("JAMS RULES"). THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN MICHIGAN. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN THE CITY OF DETROIT.
